The FDC Test is open to all dogs at least 9 months of age on the test day and must be individually registered with the AKC, recorded in the FSS program, have PAL numbers or be enrolled in the AKC Canine Partners

Program Limited Entry: Limited entries of 10 dogs per test. Closing date: 8pm, Dec. 8, 2021, after which time entries cannot be accepted without incurring a \$10 fee per run, and may not be cancelled, altered or substituted. Changes, additions, corrections, or cancellations of entries must be received in writing (US Mail or email) prior to close of entries. Entries sent via Express Mail must have the signature waived. Online entries must be signed and may be emailed to the Test Secretary email at k9cation@gmail.com. One dog per entry form. Run order will be posted at check- in table.

The tests will be conducted on a working horse ranch. Sheep and/or Geese, and ducks will be utilized for the test.

ENTRY FEES: \$75 per dog, per test (2 tests required to title) All fees payable to K9cation. Entries may be paid online via **K9cation.com/booknow.**

Day of entries accepted if trial limit 10/trial not reached.

NO Lunch available on premises, please bring your own. There may be a short lunch break at the judge's discretion. Subway, Carls Jr., Ben's Brick Oven, and the Pepper Pod restaurant are located about 10 minutes away in the town of Hudson. Dog friendly hotels are located in Brighton, Co about 20 minutes from the show site. Dry camping is unavailable for this event.

Dogs are to be on leash at all times unless confined to crate, kennel or vehicle. No dogs allowed in or near the test course except for the dog being tested. Females in season may not enter or be on the show grounds.

Children must be under direct adult supervision at all times. • K9cation, it's officers and members assume no responsibility for any loss, damage or injury sustained by an exhibitor, handler, dog, property, child, or spectator. Trialing is inherently dangerous; ground/footing is uneven. Knowing this, you assume full liability for yourself, dog, and stock if any damage is caused by you or your dog to stock or others. By attending this event on private property, you agree to clean-up after your dogs AT ALL TIMES and remove any/all trash items upon departure.

Entry fees will not be refunded if the trial(s) cannot open or be completed by reason of riots, civil disturbances, fire and/or dangerous weather conditions, acts of God, public emergencies, acts of a public enemy, strikes, COVID-flare- up, or other causes beyond the control of HPASC. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by the Trial Committee. Exhibitors must be in good standing with AKC and/or K9cation.

Smoking is restricted: Please no smoking unless you're 30' from our facilities, hay, etc. Portajohn will be on-site.

This is a fun event to do with your well-mannered dog! The Farm Dog Certification Test is designed to allow you to exhibit your dog's stability and good manners in a farm/ranch setting around livestock. You will take your dog, on lead, through a variety of exercises at 12 stations throughout the ranch.

Directions: From I76, take State Highway 52 East, turn South onto County Road 47 and go about 3 miles, facility will be on the East side of the road with signage at each driveway.
